1. ORGANIZATION

A. CALL TO ORDER

President Kresge called the meeting to order at 3:30 p.m.

B. FLAG SALUTE

The salute to the Flag was led by Josh Schultz.

C. VISITORS

Visitors were welcomed to the meeting.

D. APPROVAL OF THE AGENDA

E. APPROVAL OF MINUTES

F. COMMENTS BY THE PUBLIC

There were no comments from the public.

2. PUBLIC HEARINGS

A. A public hearing was opened at 3:35 p.m. on the final Local Control and Accountability Plan (LCAP) for 2019-2020 through 2021-2022. The LCAP and annual updated template are intended to provide details regarding the County Offices actions and expenditures to support pupil outcomes and overall performance. The final LCAP is presented for the purpose of accepting public input prior to the adoption under Item 4.A. and prior to the adoption of the final budget under Item 4.B. The public hearing elicited no comments from the public and was closed at 3:45.

B. A public hearing was opened at 3:46 p.m. on the Napa County Office of Education's final 2019-20 budget. The final budget is presented for the purpose of accepting public input prior to the adoption of the final budget under Item 4.B. The public hearing elicited no comments from the public and was closed at 3:58 p.m.

3. CORRESPONDENCE, COMMUNICATIONS, AND REPORTS

- Dr. Nemko invited Padma Helton, teacher from Shearer preschool, to speak on behalf of the preschool program.
- Ms. Helton spoke about how Footsteps2Brilliance and Math Shelf curriculums have revolutionized preschool students learning. Dora Casas, associate teacher at Shearer preschool, spoke about how the program has benefited the preschoolers as well as her own children's language development both in Spanish and English. Three parents spoke on the benefits of the curriculum and activities for their children.
- Dr. Nemko reported that the NCOE will be subcontracting with the Napa Valley College to operate their infant, toddler, and preschool programs. These programs are funded through the State of California.
- Dr. Nemko reported that our ACE Summer Camp is operating free summer camps at Harvest for 270 students for 23 camp days. Our program for siblings at Harvest is much larger than usual with students of all ages. The students are provided breakfast, lunch, and a snack.
- Dr. Nemko reported that we did a victory lap with our preschools who reached the 1 million word milestone. Calistoga preschool sent a big poster with a picture of all of the preschoolers reading the books.
- Dr. Nemko reported that bids for the Calistoga Preschool relocation project were due on Thursday, but they had to add an addendum for concrete work. Thus far, we expect seven bidders on the project.
- Dr. Nemko reported that we met with the Napa Valley College and the adult school to review the Learning Upgrade adult literacy app. Last week we met with the heads of community agencies who come in contact with the population to get them on board with the adult literacy app. Tomorrow we will meet with Father Mora at St. John's Parish to introduce him to the app for his parishioners.
- Dr. Nemko reported that 57 teachers are doing externships this summer in the health, hospitality, and wine industry with the goal of turning our teachers into career advocates for students. NapaLearns is funding this and paying the teachers \$150/day. Teachers have to write a journal about what they're learning and incorporate it into lesson plans.

C. On a motion by Mrs. Waldinger and a second by Mrs. Biederman, the Board approved the update to Administrative Regulation 5117 – Interdistrict Attendance Appeals. *Ayes* – Mrs. Waldinger, Dr. Haslip, Mr. Huffman, Mrs. Biederman, Mrs. Kresge, and Mrs. Cash. *Noes* – None.

D. On a motion by Mrs. Cash and a second by Dr. Haslip, the Board adopted Resolution 2019-11: to appoint a retired annuitant employee within 180 days of

their retirement, to fill a critically needed role. *Ayes* – Mrs. Waldinger, Dr. Haslip, Mr. Huffman, Mrs. Biederman, Mrs. Kresge, and Mrs. Cash. *Noes* – None.

E. On a motion by Dr. Haslip and a second by Mrs. Cash, the Board approved the Provisional Internship Permit (PIP) request for 2019-2020 school year. *Ayes* – Mrs. Waldinger, Dr. Haslip, Mr. Huffman, Mrs. Biederman, Mrs. Kresge, and Mrs. Cash. *Noes* – None.

F. On a motion by Mrs. Waldinger and a second by Mrs. Biederman, the Board approved the LCAP Federal Referendum. *Ayes* – Mrs. Waldinger, Dr. Haslip, Mr. Huffman, Mrs. Biederman, Mrs. Kresge, and Mrs. Cash. *Noes* – None.

The presentation is a requirement by the state to be presented as an Information Item, and then it will be submitted to the state at the same time the LCAP is submitted.
