The recipients of the approved fund distributions are:

• Superintendent's Fund: Dr. Nemko reported that the Superintendent's Fund provided a gift card for \$500 to Grocery Outlet for a family, from Pope Valley, who were evacuated to Williams, CA because of the fires.

 Donor's Choose Project: Ms. McClure reported on the Donor's Choose Project and directed the Board to the expenditures listed on the NCOE Foundation Monthly Financial Statement for further details. Ms. McClure noted that we are still working on getting all of our projects funded, and we are pleased to announce that one of the projects was funded. Ms. McClure further noted that the process requires the Foundation to contribute half the funds, and then the Kellogg Foundation matches the other half for different middle school related projects. The first project was funded for a variety of different types of gym equipment and games for Camille Creek students to use. There is a list in the agenda that will show all that was purchased from this fund. We have two more projects that are working their way through their system, and Community Programs will be the recipient of those funds.
