B. On a motion by Mr. Schultz and a second by Ms. McClure, the Board approved Consent Agenda Item 3.B. (Grant Approval): Olympic Club Foundation Grant, and the Sonoma County Vintners Foundation Grant. *Ayes* - Mr. Schultz, Dr. Apolloni, Ms. Miller, Ms. Silva, Ms. Sitch, Ms. McClure, Ms. Vaughan. *Noes* - None.

Ms. Sitch noted that the Olympic Club Foundation Grant application is for \$12,000 to cover equipment costs of a physically distanced activity for students.

Ms. Sitch further noted that they requested \$20,000 from Sonoma County Vintners Foundation Grant to support student programming for their partners in Sonoma County.

On a motion by Mr. Schultz, with an amendment to the motion noting that the *Mural for Calistoga Preschool* distribution amount is \$1,300 instead of \$1,000, and a second by Ms. McClure, the Board approved Consent Agenda Item 3.D. (Fund Distribution): Superintendent's Fund \$2,000 for Mother Goose Artwork for Calistoga Preschool; and, Superintendent's Fund \$1,300 for Mural for Calistoga Preschool). *Ayes* - Mr. Schultz, Dr. Apolloni, Ms. Miller, Ms. Silva, Ms. Sitch, Ms. McClure, Ms. Vaughan. *Noes* - None.

A. NCOE Foundation Monthly Financial Report
